

Privacy Policy

This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use the information provided by you, to us, chiefly to communicate with you and to collect donations. We may also use your personal information for improving the site. By using the site, you agree to the collection and use of information in accordance with this policy.

Information Collection and Use

Cookies

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like with many sites, the use of "cookies" can be used to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

In addition, we may use third party services such as Google Analytics that collect, monitor and analyse this data to better understand our customer's needs.
